### Installment Plan Details:

Payment #1 – 35% of registration and 100% of materials fees and shipping will be charged at time of registration  
Payment #2 – 35% of registration will be charged seven (7) business days before the first day of the program  
Payment #3 – 30% of registration will be charged seven (7) business days before the day of program assessment  
If I choose to defer my assessment, payment is still due at the originally scheduled charge date. Additional assessment deferment fees will apply.

Immediately notify Peak Pilates if program participation must be cancelled or postponed. If I cancel my registration at least seven (7) business days before the first day of the program I will be reimbursed the 35% of registration that was charged. I acknowledge that I will not be reimbursed for my materials fees unless they are returned unopened. Shipping fees will not be reimbursed. If I fail to cancel my registration before the first day of the program, I forfeit all payments that have been made to-date. If I start the program and cancel my participation before the assessment, I forfeit all payments that have been made to-date. If the program as scheduled is cancelled or postponed by Peak Pilates, student can request a full refund and return materials or apply first payment to registration for another scheduled program.
